A. Scholarships per country

1. BELGIUM (French Community)

One (1) scholarship to attend a summer seminar on Greek Language and Culture.

2. BULGARIA

- a) One (1) scholarship for undergraduate studies, including renewal, which takes precedence over granting a new scholarship.
- b) One (1) 10-month scholarship for postgraduate studies or research, including renewal, which takes precedence over granting a new scholarship,
- c) Four (4) scholarships for attending a summer seminar on Greek Language and Culture.

3. ISRAEL

- a) One (1) scholarship for postgraduate studies or ten (10) month research,
- b) One (1) scholarship for attending a summer seminar on Greek Language and Culture.

- a) Two (2) scholarships for postgraduate studies or research up to ten (10) months,
- b) Three (3) scholarships for attending a summer seminar on Greek Language and Culture.

7. SLOVAKIA

- (a) Fifteen (15) months of scholarship for research, apportioned suitably to the candidates. The maximum duration of the scholarship may be ten (10) months and the shortest may be five (5) months.
- b) Two (2) scholarships for attending a summer seminar on Greek Language and Culture.

8. SLOVENIA

- a) One (1) scholarship for postgraduate studies or research, lasting ten (10) months.
- b) Two (2) scholarships for attending a summer seminar on Greek Language and Culture.

9. CZECH REPUBLIC

Two (2) scholarships for attending a summer seminar on Greek Language and Culture.

- B. Financial benefits for undergraduate and postgraduate grant-holders
- a) Monthly grant:
- 400 € for undergraduate grant-holders and
- 450 € for postgraduate grant-holders or researchers.
- (b) Lump sum for installation costs:
- 500 € for those who settle in Athens and
- 550 € for those who settle in the province.

Grant-holders from whom the scholarship is being renewed, will not receive the above amounts for installation costs.

- c) A lump sum of 150 € per year to cover travel expenses within the country for postgraduate students or researchers who are obliged to move from their place of residence in order to carry out the research project approved by our Agency, provided that there is a reasoned request of the supervising Professor.
- d) Exemption from tuition fees applies only to undergraduate studies.
- e) It is clarified that grant-holders for postgraduate studies or research are not exempt from the relevant tuition fees in case they wish to attend Greek Language courses. Grant-holders

are required to choose <u>postgraduate study programmes offered without tuition fees</u>. In case the grant-holder opts for enrolment and attendance of a postgraduate programme for which tuition fees are required, he/she undertakes the obligation to pay them.

f) Free medical care in the event of an emergency and only in public hospitals. Citizens of EU Member States are required to produce the European Health Insurance Card.

It should be noted that financial benefits vary in relation to the economic and social conditions of our country. Grant-holders must provide the Greek Tax Authority with a Tax Identification Number (TIN), which they will receive from the Financial Services of Greece within a (1) month after their arrival.

Meals and other 'subsistence' expenses are covered by checks paid by the Bank of Greece or into a bank account in Greece, the IBAN of which is communicated by the grant holder to the Greek authority responsible for paying the scholarship. Please note that the payment of the scholarship for the first 2 months after the arrival of the grant-holder may be delayed. C. Conditions for awarding the scholarship

General

Applicants submit an application for a grant under the Bilateral Educational Programmes, the competent bodies for this purpose in their home country, in particular the Ministry of Foreign Affairs or the Ministry of Education. Subsequently candidates are selected and proposed, and their candidacy files are forwarded accordingly.

Each country's proposals, along with the files of the proposed candidates are sent by a registered letter to the Directorate General of Higher Education/Organisational and Academic Development/Department D' of Student Affairs and Scholarships of the Ministry of Education, Research and Religious Affairs, 37, A. Papandreou street, GR 151 80 Marousi (office 1063) until April 28, 2018.

Each country determines the deadlines for the submission of grant applications in accordance with this Invitation, which precede the above deadline for sending the files to the competent Hellenic authority.

The selected grant-holders must appear to the Directorate of Organisational and Academic Development/Department D' of Student Affairs and Scholarships of the Ministry of Education, Research and Religious Affairs upon their arrival in Greece in order for their scholarship to get under way. In case the grant-holder attends a study programme in Greece at a regional Higher Education Institution and resides in the province, s/he informs about his/her arrival and the details of his/her stay in Greece by e-mail to foitmer.yp@minedu.gov.gr and sends a relevant attestation from the Registry of the School s/he is attending.

Furthermore, grant-holders are required to contact the Department of Organisational and Academic Development/Department D' of Student Affairs and Scholarships of the Ministry of Education and Research at the above email address at least one (1) month prior to their arrival and notify them about the exact date. The payment of the scholarship will start from the date when the grant-holders are presented to the Directorate of Organisational and Academic Development/Department D' of Student Affairs and Scholarships, Ministry of Education, Research and Religious Affairs or inform about their arrival and not retroactively.

Age limit

2. Conditions for granting scholarships for postgraduate studies or research

These scholarships are aimed at graduates of higher education institutions who wish to undertake postgraduate studies or research work at higher education institutions or research Centres in Greece.

In order to conduct research, grant-holders must be enrolled in a doctoral or postgraduate degree in their country of origin. In the case of a postgraduate or doctoral programme in Greece, the commencement of studies is the same as when the grant was awarded. It is noted that the above procedure does not include medical specialization.

The scholarship is granted only during the academic year for which it is being awarded. The above scholarships are not renewed for more than one (1) year for postgraduate studies and two (2) years in case of a doctoral degree.

For the renewal of the scholarship, the grant-holder applies to his/her country of origin, which is competent to propose the renewal of his/her scholarship to the Higher Education Directorate/Directorate of Organisational and Academic Development/Department D' of Student Affairs and Scholarships, Ministry of Education, Research and Religious Affairs within one (1) month from the submission of the application by the grant-holder.

An application for renewal is also submitted to the Directorate of Organisational and Academic Development/Department D' of Student Affairs and Scholarships, Ministry of Education, Research and Religious Affairs, by the relevant grant-holder.

Throughout the duration of his/her scholarship, the grant-holder is obliged to remain in Greece and be dedicated exclusively to the completion of the programme of studies as submitted and approved when awarding the scholarship. The grant-holder may be absent from Greece only during the official holiday and summer holidays or for a limited period of time for research purposes, after informing the Department of Organisational and Academic Development/Department D' of Student Affairs and Scholarships, the Ministry of Education, Research and Religions Affairs. After the expiration of the grant period, each grant-holder is required to submit an analytical report showing the completion of his/her postgraduate studies or research, as well as a certificate from the supervising professor on his/her research.

Candidates for postgraduate studies in Greece should have a good knowledge of the Greek language (unless the postgraduate programme is taught in English) and have been admitted in a postgraduate course.

Candidates for research should have a good knowledge of Greek, English or French.

3. Conditions for granting scholarships for undergraduate studies

Grant-holders who are going to complete a full-time undergraduate course in Greece are initially awarded a scholarship for one (1) academic year in order to attend Greek language courses (if they do not already have a language certificate). In the event of a failure in the examination for the knowledge of the Greek language, the scholarship is interrupted, while in case of success a scholarship is granted for a full course of undergraduate studies, which will be renewed each year.

Throughout the duration of his/her scholarship, the grant-holder is obliged to remain in Greece and be dedicated exclusively to the completion of the programme of studies as submitted and approved when awarding the scholarship. The absence of up to two (2) consecutive months during the summer is justified. If the grant-holder is absent for a period longer than the above period, he must inform the Department of Organisational and Academic Development/Department D' of Student Affairs and Scholarships, Ministry of Education, Research and Religious Affairs, of the reasons for his/her absence.

During the first year of his/her stay, the grant-holder is placed in a Higher Education Institution, according to the preference list he has completed in his/her scholarship application (see (a) Supporting documents for undergraduate studies). The application has the validity of an affidavit. It is allowed to change the Department/School with a new application of the grant-holder in our country, only during the year of learning the Greek language.

It is noted that after the first year of successful attendance of Greek language courses, the grant-holder will submit in person the necessary supporting documents for registration in the Department of his/her choice. For this reason, he must hold certified copies of all the original and translated documents submitted for the award of the scholarship.

A scholarship for undergraduate studies is granted for a period equal to the normal attendance, as provided for in the programme of studies of the School/Department of

Higher Education. The grant-holder is entitled to apply for an extension of his/her scholarship up to one (1) year in addition to the aforementioned time period. The application is submitted from May to the end of June in the Department of Organisational and Academic Development/Department D' of Student Affairs and Scholarships, Ministry of Education, Research and Religious Affairs. In order to approve or reject a renewal request, the full academic record of the grant-holder, which s/he must submit with his/her application, shall be taken into account.

Our Agency grants a scholarship until the month of the graduation ceremony, in case the student completes his/her studies during the minimum length of studies. In cases where the student exceeds compulsory attendance period, the scholarship is granted only until the date of completion of the obligations arising from his/her programme of studies, and not until the graduation ceremony.

Each grant-holder is obliged to submit to the Directorate of Organisational and Academic Development/Department D' of Student Affairs and Scholarships, Ministry of Education, Research and Religious Affairs, at the end of each examination period, a detailed study certificate ("transcript"), which shows that has completed a sufficient number of courses, according to the programme of studies of the School/ Department which he/she is attending. In case of unsatisfactory progress, the scholarship is not renewed. In particular, satisfactory performance means the successful examination of at least 70% of the compulsory or elective courses provided by the programme of studies of the Department or of the School. The student is required to attend all the examination periods of his/her School as long as he/she has due courses.

- Scholarships for a summer seminar on Greek Language and Culture
- a. The venue and timing of the seminar will be announced by June 15, 2018 with a later announcement.
- b. The scholarship covers all costs (tuition fees, accommodation, subsistence, participation in cultural events), except for the costs of coming and going from Greece, which are borne by the grant-holders themselves or their country of origin.
- c. The choice of the University to organize the summer seminar is done by the Minister of Education, Research and Religious Affairs, following a suggestion from the Department of

D. Supporting documents

All supporting documents are officially translated and authenticated in Greek or French or English in duplicate. In the case of false certificates, simple photocopies or insufficiently documentation, candidacy is rejected. Our service returns the supporting documents to the applicant only at his/her request within one (1) year from the date of submission.
